I James Lawrence hereby stand by my Complaint ECF 1 and all the Responses and Exhibits from ECF 17 and ECF 20 presented in reference to Hearst's Motion to Dismiss ECF 14. I hereby disagree with the defendant's arguments for dismissal, and stand by the allegations of my complaint and material I have begun to bring forward as being more than sufficient to allow this case to proceed to trial.

As for the supposed agreement of parties not to share Discovery before the Motion to Dismiss decision, being Pro Se I am still somewhat confused as to this maneuver by Defense. The Exhibits I have shared in Responses ECF 17 and ECF 20 are essential aspects of my arguments for the case to proceed, and the nature of the types of evidence that I have submitted vary. This agreement about sharing Discovery evidence came after ECF 17 and ECF 20 and so I hope all Exhibits up to the submission of the Case Management Plan are read and reviewed for they are essential in support my positions.

Finally according to Rule 7(a)2:

“And shall indicate in the lower margin of the first page of such memorandum whether oral argument is requested.”

I believe a Hearing for this Motion to Dismiss would be in order given the various issues I have presented and need to possibly aid Judge in processing all the details presented given the fact I am Pro Se apt to have unique methods like the nature of some of my writings and lack of

experience in legal proceedings. Before this 2018 fiasco I never sued anyone and have never been sued ever. **So YES I James Lawrence would like to formally ask for a Hearing on Hearst's Motion to Dismiss.**

Also I will respect Rule 7(a)5:

“Except by order of the Court, memoranda shall be double-spaced (except headings, footnotes, and block quotes) etc...”

Being Pro Se I will have a few unorthodox ways I present my arguments. My use of single spacing (what appears actually to be 1.5 spacing) will end as of now and I will obey the double spacing rules. I truly have a hard time with presenting a case in such a rigid way given the prodigious amounts of evidence I have to share but will be cognizant of Rule 7(a) for the remainder of the procedure.

MORE CONCLUSIONS (See ECF 1, ECF 17, ECF 20)

To conclude this document, I wish to add some more perspective. We live within a unique time of certain types of reckless bias as I have introduced within this case. Currently there is utter chaos because one horrible act of misconduct from one policeman from one police department from one town (Minneapolis) from one state of the country has made its way into the national psyche and world at large. Now around the country some people in this age of relative **victim playing** are using this one horrible incident (before Due Process of Law) to create utter havoc and damages via **their own very special sense of justice**. Some examples of the extreme and senseless damages – businesses looted and destroyed, public monuments vandalized, innocent people attacked and beaten to death, and policemen killed because of this one horrible incident from one officer from one police force from one town within one state. Extreme mobs all over are now looking to defund police. This is the age we are in – Internet search – readily available information at breakneck speed and this is a very telling example of the effects it has on our lives and how a piece of information can go “viral” and cause various kinds of damages.

Issue: Pushing one’s very own special sense of justice before Due Process of Law.

What gives people the right to act this way?

What causes or encourages people to act this way?

How does someone else’s business/case justly become everyone else’s business/case?

I deserve to show how Hearst Communications’ reckless and damaging let alone unproven and un-provable accusations/actions against me has done to my life. A main antagonist of the persecution against me is the woman who approached Hearst - Wendy Higgins Chambers – the woman who read about me in the news and then went to News 12 Ct./Altice (of all people) who proceeded to (as has been established by a federal judge) “unfairly” and “outright falsely” and yes slanderously report on me only to **take down their special coverage within 2 days** and

scrub their website of their coverage of me. Wendy Higgins Chambers then goes to the police who do not even make an individual police incident report for her arguably **victim playing** lies of me being “*a creep handing her a business card at a market*” all the while the police being fully empowered to take action under the statute of limitations. Wendy Higgins Chambers then 9 days later (knowing I was already damaged from the News 12 persecution let alone already in the system for Due Process of Law) goes to the Westport News/Hearst Communications and they together collude to make another persistent persecutory special story before Due Process of Law and after Due Processes of Law (any past incident devoid of any arrest after thorough investigation cases long closed) again **knowing I was already harmed** from a previous attempt at a special story by this same woman and only this woman – Wendy Higgins Chambers.

Yes the only woman/name is Hearst’s special **supermarket** subject Wendy Higgins Chambers, for the woman from the March 5, 2018 supermarket related arrest never stepped up as witness with a sworn written statement and wanted nothing to do with the arrest resulting in being not guilty of the Second Degree Breach of Peace charge maintaining my clean Ct. record especially in regard to the matters at hand in this case. Why did the alleged woman from the supermarket not come forward? Most likely she knew the triviality of the accusation – a supermarket encounter devoid of words, which is why I once again would invite Hearst to attempt to bring anyone to court to prove their “*harassed women for years*” accusations/charges, for the police themselves will never say that I “*harassed*” anyone given no prior arrests for anything including harassment let alone the actual wording within the dubiously ascertained arrest warrant for one count of Second Degree Breach of Peace of “*getting into personal space*” (See ECF 17, 20). Victimhood Culture - notice the year – **2018** – the same time as my arrest and very out of the ordinary resulting Hearst persecution. I ask Hearst bring forth any proven victim.

Victim playing is a term dealt with by various books now that became more popular around 2018 – the time Hearst attempted their SPECIAL report of me before (and after) Due Processes of Law. Obviously some of this recent victim playing is a blowback from extreme aspects of the post 2016 election MeToo Women’s Marches as well as other issues not related to the Women’s Marches where people have been increasingly deploying social media and the Internet to vent personal issues (some justified and some called “snowflake” issues) with the intent to get some kind of new actions around their personal causes. We now have even more examples of victim playing with the opportunistic exploitation of the extreme and chaotic rioting from various groups because of one Minneapolis policeman’s horrific misconduct.

This victim playing phenomenon is very much related to the social media mobbing that is also a special aspect of the times. The law should keep extremist social media trends from dictating the ways of the more respectable mainstream media. I believe this obvious angry knee-jerk finger pointing and victim playing zeitgeist should also be put on display and put to the test within my case. I too have stories if not hard evidence of what Hearst’s unproven and unprovable special story of me *“Police: Man Harassed Women for Years”* has done to my name and life as it went viral. Police never said/deployed these words in the dubiously ascertained March 5, 2018 arrest warrant, and never will testify they previously said or meant this for obvious reasons I have begun to present. There are far too many lingering questions. My case and evidence deserves a jury of my peers.

I mention these obvious extreme forms of victim playing going on in this country because it is time the courts wake up and realize the Internet is creating the need for some sensible and

tough decisions in tune with the times around certain types of defamation. We truly are in a new age via the Internet, for people are naked and constantly being “Googled”, and depiction of people or events by the largest and most influential media like Hearst/API – articles that show up in searches around a particular name – best move toward more responsible journalism based on established facts and not falling to the standards of personal feelings from the likes of Twitter tweets or Facebook postings. We cannot allow for special hit jobs with **extreme and conflating language** devoid of any proper evidence let alone evidence in general. **Conflating a particular incident** (in my case an innocuous act resulting in being not guilty of Second Degree Breach of Peace – not criminal nor ever criminal – past “incidents” devoid of an arrest) is a huge problem now and it is up to the courts to reign in this mad zeitgeist.

Yes we are in a time of some very disturbing instincts to conflate and it is obvious how Hearst’s 22 year-old reporter Sophie Cecilia Vaughan is guilty of various types of confluations against me. We truly live in a time of various troubling instincts to conflate issues for personal agendas.

Examples of conflation include:

- A police misconduct at one time by one officer is reason to defund and dismantle police or riot at others expense because individuals believe systemic problems exist in all police departments from all cities.
- My case against Altice USA (who took down their “unfair” and “outright false” coverage of me in 2 days) is absolutely similar to my case against Hearst Communications (never taken down).
- The words “harass women” are absolutely similar to “getting into a woman’s personal space”.
- Charges for one count of Second Breach of Peace are absolutely similar to charges for Harassment or Stalking.
- Alleged Second Degree Breach of Peace is a form of MeToo sex harassment.
- Mere past arrests can be reported on as being or insinuating convictions of something.
- Social media feelings are equal to necessary and responsible hard news from major media.
- Someone being politically alt-right is somehow labeled an extreme fascist or someone being politically alt-left is somehow being some kind of extreme communist.
- Someone part of a political party like Republican or Democrat absolutely lines up within the particular party’s agenda.
- Someone who is African or European or Hispanic, etc... absolutely lines up with all identity politic causes let alone opportunistic narratives that conflate at no matter what expense.
- Someone who is female absolutely lines up in identity politic ways with all women’s causes,

- Etc...

Truly mindsets of children.

We now have because of this perfect storm of political feelings fused with smart phones/Internet various **persecutions** happening that is truly making the masses more confused and allowing for more and more types of chaos and angers. One extreme begets another. The country is rife with and dumb down with identity politic madness. For example, an announcer for the Sacramento Kings basketball team was forced to resign, as was an actual pastor, because they expressed “all lives matter” despite the fact that this statement is innocuous – all lives do matter. Many are victims of police misconduct like many are victims of media misconduct. In another disturbing recent story, an editor of a newspaper was forced to resign because he tweeted “all buildings matter”, which he shared as a means to stop extremists from **conflating** others’ property with the real culprits of the tragedy. We are truly within an insane time. We have had 4 months of social distancing to protect each other, and now people are recklessly and violently gathering to vent their own feelings (much not about the police misconduct) thereby endangering others by not respecting the need to continue the relative forms of social distancing supposedly mandated by their public officials. Meanwhile Malibu police ticket surfers \$1,000 apiece for using the ocean during the quarantine. Why are all these various types of hypocritical actions happening and why are they allowed to happen? How do these storms against common sense like not respecting Due Process of Law and in my case Innocent Until Proven Guilty allowed to happen?

I believe there are far too many current issues, unresolved issues, and ambiguities within this James Lawrence v. Hearst Communications case to dismiss it without hearing as many witnesses (if Hearst themselves can actually bring anyone) and seeing as much evidence as possible thus





I mean really, given I have no conviction what is my legacy after this type of reporting that never would have happened prior to 2018?
